### Horseshoe Lake Wildlife Structure Replacement

Bids for the construction of the Project will be received at the Two Rivers Watershed District office located at 410 5th St SE # 112, Hallock, MN 56728, until Wednesday, June 26 at 3 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Remove the existing structure including a concrete weir box, 36" x 17.5' steel walk bridge, 54" corrugated steel pipe culvert, all appurtenances. Provide a replacement structure including a reinforced concrete inlet structure, 54" reinforced concrete pipe culvert with apron, 4-foot by 3-foot sluice gate, steel platform, aluminum stop logs and bay.
